VII. CEO/QUALITY/RISK MANAGEMENT REPORT

- 1. Suzanne gave the Quality and Risk Management reports.
- 2. Mercy Health Network announced the merger with the Wheaton Franciscan Healthcare hospitals and clinics. Wheaton Franciscan Healthcare includes Covenant Medical Center, Waterloo; Sartori Memorial Hospital, Cedar Falls; and Mercy Hospital of Franciscan Sisters in Oelwein.
- 3. Two members of the DCH Board, two members of the Community Health Centers of Southern Iowa board, and the organization's CEOs met on November 2 in Lamoni to develop a plan for the

hospital and clinic to collaborate on needs identified in the Community Health Needs Assessment.

- 4. DCH, Decatur County Public Health, Community Health Centers of Southern Iowa, and CROSS Mental Health Region hosted the Community Health Needs Assessment community forum on November 18th at the Country Club in Leon. The event was held to identify and prioritize the health needs of the community. A final plan for health priorities from the community forum was presented to the Board.
- 5. Decatur County Hospital hosted students from the Health Occupations classes of Central Decatur High School and students from Lone Tree High School in Lone Tree, Iowa to learn about different careers in health care and learn from DCH staff in the clinical setting.

VIII. FINANCIAL REPORT

Tara Spidle presented the financial report for the month of October. Total operating revenue for October was \$1,027,510 with operating expenses totaling \$1,106,443. Non-operating revenue was \$59,208. Net loss for the month was (\$19,725). Year to date net loss is (\$215,764). It was moved by Linda Chastain and seconded by Rudy Evertsen to approve the financial report.
